(Act No. 7 of 2016)

{Received the assent of the Governor of Mizoram on the 31st August, 2016}

THE MIZORAM ROAD FUND (AMENDMENT) ACT, 2016

AN ACT

to amend the Mizoram Road Fund Act, 2007

It is enacted in the Legislative Assembly of Mizoram in the sixty sixth year of the Republic of India as follows:

Short Title, extent and Commencement	1.	1) 2) 3)	This Act shall be called "The Mizoram Road Fund (Amendment) Act, 2016. It shall have the like extent as the Principal Act. It shall come into force from the date of its publication in the Official Gazette.
