#### NOTIFICATION

**No.H. 12017/130/2014-LJD/Pt, the 4<sup>th</sup> October, 2016.** In exercise of the powers conferred under sub-section (3) of section 4 of the Mizoram Lokayukta Act, 2014, the Selection Committee constituted under sub-section (1) of section 4 of the Act is pleased to notify the constitution of the Search Committee to prepare a panel of persons to be considered for appointment as Chairperson and Members of the Lokayukta, as follows :-

  - iv) Dr. L.H. Chhuanawma, (Associate Professor, PUC), Zotlang, Aizawl.
  - v) Pi Laltanpuui (Lecturer, Rtd. Govt. Aizawl College), Tlangnuam, Aizawl.
  - vi) Pi Tlangthanmawii, Zarkawt, Aizawl.
  - vii) Pu P. Singthanga, Zonuam, Aizawl.
  - viii) Pu Vanlalruata (President, PRISM), Maubawk.
1. The term of the Chairperson and Members of Search Committee shall be 2 (two) years from date of appointment as per rule 3 of the Mizoram Lokayukta Rules, 2015.
2. The Chairperson and Members shall be entitled to a sitting fee of Rs. 1500/- for each day for attending the meeting of the Search Committee as per sub-rule (1) of rule 4 of the Mizoram Lokayukta Rules, 2015.
3. Travelling allowance as are admissible to a Secretary to the Government of Mizoram for attending the meeting of the Search Committee as per sub-rule (2) of rule 4 of the Mizoram Lokayukta Rules, 2015.
4. The term of the members as mentioned at para 1 above shall expire once the given task of preparing a panel even before a period of two years.
5. Pu P. Singthanga, Secretary (Law & Judicial) retired, is hereby nominated as the Chairman of Search Committee.
