Subject : Mizoram Chief Ministers Award to toppers of HSLC and HSSLC Examination under MBSE Scheme.

WHEREAS, it is deemed expedient that outstanding students of the State of Mizoram are given special recognition by giving cash award so that it will act as an incentive to other students to inculcate a spirit of discipline and determination amongst the students, to inspire the awardees as well as other students to strive for excellence in their future endeavours and to inculcate a sense of being looked after and a feeling of security for having excelled in his/her course of study.

NOW, **THEREFORE**, the Governor of Mizoram is pleased to make the following scheme for providing lumpsum cash award to the Toppers in High School Leaving Certificate and Higher Secondary School Leaving Certificate Examination under Mizoram Board of School Education, namely;

1.	Short title and commencement	:	 This Scheme may be called the Mizoram Chief Ministers Award to toppers of HSLC and HSSLC Examination under MBSE Scheme. They shall come into force on the date of publication in the Official Gazette.
2.	Definitions	:	 In this Scheme unless the context otherwise requires- 'Director' means Director of School Education, Mizoram 'HSLC' means High School Leaving Certificate 'HSSLC' means Higher Secondary School Leaving Certificate 'MBSE' means Mizoram Board of School Education
3.	Eligibility	:	 The following students shall be eligible for cash Award as given in the Annexure (1) A student who ranks First in the HSLC Examination conducted by MBSE (2) Students who rank First in various streams like Arts, Science, Commerce and Vocational Education in HSSLC Examination conducted by MBSE
4.	Competent Authority	:	The competent Authority for the purpose of this Award shall be the Director of School Education

5.	Quantum of Cash Award	:	The Govt. of Mizoram shall fix the amount of cash Award for different categories from time to time as may be considered expedient
6.	Residuary power	:	In case of any situation or circumstances not specifically covered in this Scheme, the competent authority under Para 4 shall have residuary powers to make decision
