NOTIFICATION

PRELIMINARY NOTIFICATION FOR LAND ACQUISITION IN LUNGLEI DISTRICT

No.K.12011/61/2015-REV/Pt, the 19th December, 2016. Whereas it appears to the Government of Mizoram that a total of <u>208.22 hectares</u> of land is required in the villages (list enclosed at Annexure I) in the district of <u>Lunglei</u> for public purpose, viz, <u>Strengthening & Widening of NH-54 from Aizawl to Tuipang Project to be funded by JICA.</u>

Social Impact Assessment Study was carried out by State Institute of Rural Development & Panchayati Raj (SIRD & PR) and a report submitted as per Section 4 of the Mizoram (Land Acquisition, Rehabilitation & Resettlement) Act, 2016 (copy of SIA Report appended at Annexure II)

A total of <u>1357</u> families are likely to be displaced due to the land acquisition. The reason necessitating such displacement is given below:

"Construction, Widening and Improvement of NH54 from Aizawl to Tuipang to be funded by Japan International Cooperation Agency and to be implemented by National Highways & Infrastructure Development Corporation Ltd. (NHIDCL)"

<u>Additional District Commissioner, Lunglei District</u> is appointed as Administrator for the purpose of rehabilitation and resettlement of the affected families.

Therefore, it is notified that for the above said project in the villages of the district of the <u>Lunglei</u> land measuring <u>208.22 hectares</u> is under acquisition.

This notification is made under the provisions of Section 11(1) of the Mizoram (Land Acquisition, Rehabilitation & Resettlement) Act, 2016, to all whom it may concern.

A plan of the land may be inspected in the office of the District Collector and Settlement Officer of concerned District on any working day during working hours.

Objections, if any, to the acquisition regarding:

- i) The area and suitability of land proposed to be acquired
- ii) Justification offered for public purpose
- iii) The findings of the Social Impact Assessment Report may be filed by the person interested within 60 (sixty) days from the date of publication of this notification as provided under section 15 of the Act before the District Collector, Lunglei District.
