- (vi) Property Documents such as Pattas, Registered Deeds, etc.with photograph,
- (vii) SC/ST/OBC Certificate and Residential Certificate issued by competent authority (issued upto 19-1-2017),
- (viii) Pension Documents such as ex-servicemen's Pension Book/Pension Payment Order, ex-servicemen's Widow / Dependent Certificate, Old Age Pension Order, Widow Pension Order (issued upto 19-1-2016),
- (ix) Freedom Fighter Identity Card,
- (x) Arms Licenses (issued upto 19-1-2017),
- (xi) Certificate of Physically Handicapped with photograph issued by the competent authority (issued upto 19-1-2017),
- (xii) Job Card issued under MNREGA with photograph (issued upto 19-1-2017),
- (xiii) Health Insurance Scheme Smart Card (issued upto 19-1-2017),
- (xiv) Students Identity Card issued by the concerned Head of Institution.
