Terms of Office : Term of the Committee will be 3 (three) years

Function of the Advisory Committee :

The Advisory Committee may advise the Government on the following matters :

- a) Extention of the Areas under cultivation of Oil Palm.
- b) Problems relating to the cultivation of Oil Palm.
- c) Problem faced by the Oil Palm Processing Industry.
- d) Co-ordination between the Oil Plm Growers and Industry and sorting out of all matter which may arise.
- e) To bring to the Notice of the Government any measures that will suit the orderly development of the Oil Palm cultivation and Industries.
- f) It will make recommendation to the State Government on any issue relating to policy matters, administration and implementation of Programme for Consideration of the State Government.
- g) It will hold review meeting at least once in a Quarter of the term.
