NOTIFICATION

No. A.45011/3/2011-HTE(TE), the 17th May, 2017. In pursuance of the provision under section 2 and 3 of the Central Education Institutions (Reservation in Admission) Act, 2006 read with Govt. of India, Ministry of Human Resource Development, Deptt. of Higher Education's letter F.No.21-3/2016.TS-III dt. 10.03.2016, the Governor of Mizoram is pleased to notify the following reservation policy for filling up of 50% Home State Quota in the National Institute of Technology, Aizawl, namely :-

| Short title and Commencement | 1. | 1) This policy may be called "The Mizoram (Filling up of 50% Home Seats in National Institute of Technology, Mizoram Selection) Policy, 2017".
2) They shall come into force on the date of publication in the Official Gazette. |
| Selection to be done through written examination | 2. | Selection of candidates for the Central Education Institution under these rules shall be done through Joint Entrance Examination JEE (Main) with a minimum percentage of 40% to his credit. |
| Method of Selection | 3. | All applicants shall be classified into three categories for the purpose of allotment of seats, viz :-
a) 92% of the total seats are reserved for Scheduled Tribe people of the State of Mizoram and have been residing permanently in the State of Mizoram.
b) 3% of the total seats are reserved for Scheduled Tribe Physically Handicap people of the State of Mizoram and have been residing permanently in the State of Mizoram.
c) 5% of the total seats are reserved for
i) General/Scheduled Caste/Other Backward Class people who are permanent residents of Mizoram and
ii) Children of Central/Other State Government employee posted in Mizoram
d) Vacant seats, if any, due to unavailability of suitable candidates from amongst the category (b) and (c) shall be reverted back to category (a). |

- Explanation**
4. 1) "Scheduled Tribe" means the people of the State of Mizoram and have been residing permanently in the State holding Schedule Tribe Certificate and Residential Certificate issued by Mizoram Government.
 - 2) "Scheduled Tribe Physically Handicap people" means the people of the State of Mizoram and have been residing permanently in the State holding Scheduled Tribe Certificate and Residential Certificate issued by Mizoram Government.
 - 3) To be eligible to be considered under sub-clause (ii) of clause (c) of rule 3, the current posting of the Government servant in Mizoram should be atleast for two (2) consecutive years.
- Allotment of Seat**
5. 1) All the selected candidates will be required to appear in person before the Counselling Authority Central Counselling Advisory Board (CSAB) for counselling and checking of all the documents (Residential Certificate, Tribal Certificate, Educational Certificate) in original on the date, time and venue to be intimated to Director, Higher & Technical Education. The candidates who fail to produce such original documents at the time of personal appearance, allocation of seats shall be liable to be rejected. The vacant seats if any shall be filled up by the next deserving candidate from amongst the category.
 - 2) If any candidate is found to have furnished false information of certificate(s) or to have withheld or concealed any material/information to gain personal advantage, he shall be disqualified. If selection or even admission has already been done or effected, it shall be cancelled at any stage of his study and such other action as deemed necessary may be taken against him, under any law for the time being in force in the State of Mizoram.
- Repeal and Saving**
6. On and from the commencement of this policy the Notification No.A.45011/3/2011- HTE(TE) dt. 11.04.2016 shall stand repealed.
- Provided that any order made or anything done or any action taken under the Notification so repealed or under any general orders ancillary thereto, shall be deemed to have made, done or taken under the corresponding provisions of this policy.
