Terms of Office of the Committee :

The term of office of the non-official members of the Committee or any Committee appointed by the Committee shall be for a period of one year from the date of appointment, provided that a member is appointed in his capacity as a member of a particular body. He/She shall automatically ceases to be a member if he/she ceases to be a member of the body.

Proceedings of the Committee :

1. The Chairman of the Committee, when present, shall preside over all the meetings of the Committee.
2. If the Chairman is unable to preside over the meeting, his representative shall preside over the meeting of the Committee.
3. Not less than a week's notice of every meeting of the Committee shall ordinarily be given to each member, but a shorter notice may be given for emergency meetings.
4. The Committee shall meet as often as necessary.
5. The agenda of every meeting shall be sent so as to reach the members at least a week before the scheduled date of meeting.
6. The Chairman may, in special circumstances instead of convening a meeting of the Committee, obtain the views of the members on any item of business individually by circulation.
