No. K. 12011/61/2015-REV/Pt, the 4th May, 2017. In the interest of the public, the Governor of Mizoram is pleased to hereby notify for general information and compliance that the Notification issued under Section 11(4) of The Mizoram (Land Acquisition, Rehabilitation and Resettlement) Act, 2016, vide No. K. 12011/61/2015-REV dated 6.1.2016, for freezing of status of land within 100 metres of the road on both sides along the NH-54 (Aizawl to Tuipang), shall not apply to the lands for which approval for allotment or issuing of land pass was already granted by the Government or appropriate authority prior to the date of issue of the said Notification.

The approved land passes which have been kept pending due to the said notification as mentioned above may, therefore, be issued by realising taxes on land, with interest for the period with effect from the dates of such approvals. However, the nature of the pass or ownership shall not be altered from its condition at the approval stage till completion of the acquisition process.
