The Appropriate Authority shall perform the following functions as per section 13(3) of the principal Act namely :

- (i) to grant registration under sub-section (1) of section 15 or renew registration under sub-section (3) of that section;
- (ii) to suspend or cancel registration under sub-section (2) of section 16;
- (iii) to enforce such standards, as may be prescribed, for hospitals engaged in the removal, storage or transplantation of any human organ;
- (iv) to investigate any complaint of breach of any of the provisions of this Act or any of the rules made there under and take appropriate action;
- (v) to inspect hospital periodically for examination of the quality of transplantation and the follow-up medical care to persons who have under gone transplantation and persons from whom organs are removed; and
- (vi) to undertake such other measures as may be prescribed.

And as per section 10(13B) of Amendment Act, 2011, the Appropriate Authority shall for the purposes of this Act have all the powers of a civil court trying a suit under the Code of Civil Procedure, 1908 and, in particular, in respect of the following matters, namely:-

- (a) summoning of any person who is in possession of any information relating to violation of the provisions of this Act or the rules made there-under;
- (b) discovery and production of any document or material object;

There shall be a full time Managing Director of the SERIFED LTD. appointed by the Board on such terms and conditions and with such executive powers as may be determined in this behalf Or the Managing Director may be appointed on deputation by the Board from the Sericulture Department and Cooperation Department, Government of Mizoram, in consultation with the concerned Departments. He shall have the general control over the administration of the Federation. He shall summon and attend all the meetings of the Federation and the Board or any other Committee formed by the Board in consultation with the Chairman
