2. The Project would be named '**Mizoram** District Capitals Urban Development Program (**MDCUDP**)' and each district headquarter would have a separate Sub-Project under the Program which will cover infrastructure under the following:
  - (a) Water Supply
  - (b) Waste Water Management
  - (c) Urban Transport Improvement
  - (d) Solid Waste Management
  
3. All the projects will be posed for MDCUDP under a single Externally Aided Programme (EAP) for Asian Development Bank (ADB) funding.
