NOTIFICATION

No.J.11011/3/2013-GAD, the 31st January, 2013. In supersession of Planning Department's Notification No. G. 28014/54/2006-PLG dt. 9.5.2010 constituting Aizawl District Planning Committee, the Governor of Mizoram is pleased to constitute Aizawl District Rural Development Committee with immediate effect and until further order.

- 2(i) The Committee will consist of a Chairman, a Co-Chairman, a Member Secretary, and members not more than six in number.
- (ii) The Chairman of the Committee will be appointed by the Chief Minister of Mizoram from time to time.
- (iii) Co-Chairman and <u>Member Secretary</u> shall be the Deputy Commissioner and <u>Project Director</u> <u>DRDA</u> of the District concerned, respectively.
- (iv) Members, not exceeding six, will be appointed from the prominent citizens of the District having experience and special knowledge on the recommendation of the Chairman and with the approval of the Chief Minister.
- (v) Chairman of the Committee may also invite any official concerned with planning and development in the District as special invitee.
- 3. The functions of the Committee will be as follows :-
- (i) It will formulate and implement District level plan out of the outlay earmarked as discretionary and incentive fund/separately earmarked to meet the local aspirations.
- (ii) It will also examine all District level plan proposals under normal State Plan, CSS and other funding agencies and forward to the State Planning Board along with its recommendations.
- (iii) It will undertake review and monitoring of all District level plan and projects under State Plan, CSS and under other Central Assistance.
- (iv) It will also have the power and liberty to draw up developmental projects and schemes considered necessary for the district.
- (v) It will endeavor to promote public participation and cooperation in development programmes and expand local community efforts in the area.
- 4. JURISDICTION :

Aizawl District Development Committee shall comprise all the villages within :

- (i) outside the jurisdiction of Aizawl Municipal Council in respect of
 - (a) Aizawl North I(ST) Assembly Constituency
 - (b) Aizawl North II(ST) Assembly Constituency

- (c) Aizawl East I(ST) Assembly Constituency
- (d) Aizawl East II(ST) Assembly Constituency
- (e) Aizawl South III(ST) Assembly Constituency
- (f) Aizawl West I(ST) Assembly Constituency
- (g) Aizawl West II(ST) Assembly Constituency
- (h) Aizawl West III(ST) Assembly Constituency
- (ii) All the villages within the following Assembly Constituency
 - (a) Chalfilh (ST)
 - (b) Tawi (ST)
 - (c) Tuivawl (ST)
