#### **NOTIFICATION**

**No. H.12018/83/09-LJD, the 2**<sup>nd</sup> **April, 2012.** The following Act of the Mizoram Legislative Assembly, which received the assent of the Governor of Mizoram is hereby published for general information.

The Mizoram Appropriation Act, 2012 (Act No. 5 of 2012)

[Received the assent of the Governor of Mizoram on 23rd March, 2012]

#### AN ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services during the Financial Year of 2011-2012

It is enacted by the Legislative Assembly of Mizoram in the Sixtieth Year of the Republic of India as follows:-

Short Title

Isseu of ^ 783,33,00,000/- only out of the Consolidated Fund of the State of Mizoram for the Financial Year, 2011-2012

Appropriation

- 1. This Act may be called the Mizoram Appropriation Act, 2012
- 2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting, in the aggregate, to the sum of **Rupees seven hundred eighty three crore thirty three lakh** only for defraying the several charges which will come in course of payment during the Financial Year, 2011-2012 in respect of the services specified in column (2) of the Schedule.
- 3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Scheule in relation to the said period.
