Powers & Functions of the Board of Directors :-

The Board of Directors shall have control over the financial, administrative and the Academic matters of the Schools in the following manners:-

- (1) To determine the qualification of the candidates to be recruited as the staff of the Schools and its affiliating Institutions.
- (2) To regulate the conditions of service of the staff of the School and its affiliating Institutions in respect of scale of pay, allowances, leave, sanction of advances, traveling and daily allowances.
- (3) To administer the funds of the School and manage the properties of the Schools.

- (4) To administer the procedures to enter into agreement with other agencies, home and abroad for and on behalf of the School.
- (5) To execute and approve detailed plans and programmes prepared and suggested for the furtherance of the objectives of the Schools.
- (6) To determine the procedures, terms and conditions to affiliate the Schools and any institutions having objectives similar to those of the Schools or to recognize other Institutions.
- (7) To effectively implement the Curricula, Syllabi etc. as laid down by the Education Department either by the State Govt. or the Central Govt.
- (80) To discharge such other functions from time to time as may be necessary for the proper management of the Schools.
