TERMS OF REFERENCE

A. Terms of Members

- 1. All members of the State and District Working Group for "Shiksha ka Haq Abhiyan" except those members who represent Non-Governmental Organizations shall continue to be members as long as they hold their office and cease to be members immediately as soon as they cease to hold such office. The successor in office shall become a member from the date of assuming charge of the office.
- 2. The term of members of the State and District Working Group for "Shiksha ka Haq Abhiyan" who represent Non-Governmental Organizations shall be of one year. Such members shall be eligible for re-nomination.
- 3. The members of the State and District Working Group for "Shiksha ka Haq Abhiyan" shall become members from the date on which their nominations are accepted by the Chairman of the respective Committees.

B. <u>Proceedings</u>

Meeting of the State and District Working Group for "Shiksha ka Haq Abhiyan" shall be held as often as necessary but shall meet at least once in every three months.

C. <u>Functions of State Working Group</u>

- (a) preparation of action plan for the implementation of "Shiksha ka Haq Abhiyan"
- (b) preparation of publicity material/media kits
- (c) evaluating the performance of District Working Group and Block level volunteers
- (d) monitor progress and achievement of District Working Group and Block level volunteers towards implementation of RTE Act
- (f) consolidation of district reports
- (g) broadcast RTE messages

D. Functions of District Working Group

- (a) identification of Volunteers
- (b) preparation of Volunteers Training Plan
- (c) development of Survey and Assessment Tools
- (d) preparation of Volunteers School Visit Plan
- (e) compilation and collection of data at District level
- (f) submission of compilation and collection of data to State Working Group
- (g) to visit schools and arrange meetings of Teachers, Parents, SMCs, VECs and other NGOs in the locality for necessary training/publicity.
