**Function of the Sub-Divisional Level Committee** : The Sub-Divisional Level Committee (SDLC) shall --

- Provide information to each Gram Sabha about their duties and duties of holder of forest rights and other towards protection of wildlife; forest and biodiversity with reference to critical flora and fauna which need to be conserved and protected;
- Provide forest and revenue maps and electoral rolls to the Gram Sabha or the Forest Rights Committee;
- Collate all the resolutions of the concerned Gram Sabhas;
- Consolidate maps and details provided by the Gram Sabhas;

- e) Examine the resolutions and the maps of the Gram Sabhas to ascertain the veracity of the claims;
- f) Hear and adjudicate disputes between Gram Sabhas on the nature and extent of any forest rights;
- g) Hear petitions from persons, including State agencies, aggrieved by the resolutions of Gram Sabhas;
- h) Co-ordinate with other Sub-Divisional Level Committees for inter sub-divisional claims;
- i) Prepare block or tehsil-wise draft record of proposed forest rights after reconciliation of government records;
- j) Forward the claims with the draft record of proposed forest rights through the Sub-Divisional Officer to the District Level Committee for final decision;
- k) Raise awareness among forest dwellers about the objective and procedures laid down under the Act and in the rules;
- l) Ensure easy and free availability of proforma of claims to the claimants as provided in Annexure-I (Forms A and B) of the Scheduled Tribes and Other Traditional of Forest Dwellers (Recognition of Forest Rights) Rules, 2008.
