**No. G. 16016/9/2019 - F.Est, the 14<sup>th</sup> January, 2020.** In exercise of powers conferred by sub-rule (2) of rule 3 of the Lotteries (Regulation) Rules, 2010, the Government of Mizoram hereby frames the following lottery scheme, in the interest of public service and for generation of additional revenues, through the Director, IF&SL:-
